Scholarship Policy Instructions

The International Association of Fire Fighters (IAFF) Local 2916 Benevolent is pleased to offer a scholarship program to local students and students of local IAFF members.

The applicant must meet the following requirements to be considered:

- Scholarships will be made available to ANY Mead High, Mt. Spokane High, Lakeside High School Student or Graduate*, or ANY dependent of current or retired members of IAFF Locals within Spokane and Stevens Counties.**
- Scholarships will be used for university/college/trade or other approved post high school educational expenses (e.g. tuition, books etc.).
- Applicants must be at least 16 years of age and no more the 23 years of age and must be attending or planning to attend a post high school program as outlined in the second bullet.
- Applicants MUST be entering into their INTITIAL post high school educational experience.
- Applicants must personally complete the application packet in its entirety and follow all instructions to be considered for an award.
- A conviction of a crime does not disqualify and applicant from receiving an award, but lying on the application will.
- Class ranking and GPA is a small part in this process. Most important is an exhibition of desire to experience a post high school education. ALL INTERESTED SHOULD APPLY.

Scholarships will be awarded to the top scoring applicants in order of their ranking after the scores have been tallied regardless of affiliation.

* Mead, Mt. Spokane or Lakeside High School Student or Graduate:

Enclose <u>a letter from your respective high school administrator on an official letter head</u> confirming your student affiliation status.

A copy of your student ID does not fulfill this requirement.

** If the student is not affiliated with one of these three schools then affiliation to Spokane or Stevens County Area IAFF Locals will be considered:

Enclose <u>a letter from a principal officer</u> (President, VP, or ST) of your parent or guardian's affiliate **local** confirming your parent or guardian is a member in good standing, or was at the time of his/her retirement.

A 'Certificate of Membership' from the WSCFF website does not fulfill this requirement.
